12. What is TITP?

Ans: TITP stands for Technical Intern Training Program, which allows foreign nationals to receive job training in Japan and acquire technical skills to utilize in their home countries.

13. What is SSW?

Ans: SSW stands for Specified Skilled Worker, a visa category that allows foreign nationals to work in Japan in sectors facing labour shortages. It is divided into two types: SSWI for specific job categories and SSW2 for higher-skilled positions.

14. Can I change jobs or not?

Ans: Under the SSW visa, changing jobs within the same industry is possible but requires notification to immigration authorities. For other visa types, specific rules apply and changing jobs may require a new visa application.

15. What is the average salary in Japan?

Ans: As mentioned earlier

16. What about insurance in Japan?

Ans: Health insurance and employment insurance. Insurance premiums are deducted from employees' salaries. The contribution is usually shared between the employer and the employee, though the exact split can vary.

17. What about taxes in Japan?

Ans: Tax on their earnings ranging from 5% to 45% based on income levels, municipal taxes and social insurance contributions.

18. What is the currency of Japan?

Ans: The Japanese Yen (JPY) is the official currency of Japan

19. What about the economic condition in Japan?

Ans: Japan has the third-largest economy, known for its advanced technology, manufacturing, and exports.

20. What is the petrol price in Japan?

Ans: As of July 2024, the current petrol price in Japan is JPY 176.20 per litre, which is approximately INR 94.00/litre.

21. What is the car price in Japan?

24. Can my family member stay with me?

Ans: Yes, family members can stay with you in Japan on a dependent visa. The primary visa holder must meet certain income requirements to support dependents.
